VILLAGE OF DENMARK SUMMARY

- Denmark had 85 total incidents in February
- DEO Dzekute and DEO Delebreaux handled 43 of the 85 incidents in the village (50.6%)

VILLAGE OF DENMARK PATROL

- Denmark officers continue to monitor traffic, but the number of traffic stops has gone down for the month due to extra hours in the office working on administrative items.
- DEOs made 2 traffic stops, issued 1 citation, and 1 written warning.
- County Patrol made 3 traffic stops and issued 3 written warnings
- There were two attempts made to pick up a party on an active arrest warrant during the month. The warrant has since been cancelled.

BROWN COUNTY DRUG TASK FORCE IN DENMARK

- 02-10-16 there was an investigation conducted that led to the discovery of a meth lab in the village. The Brown County Drug Task Force conducted the investigation along with WI state investigators. One person was taken into custody for the incident. DEO Delebreaux assisted with the incident.

OWI ARRESTS IN DENMARK

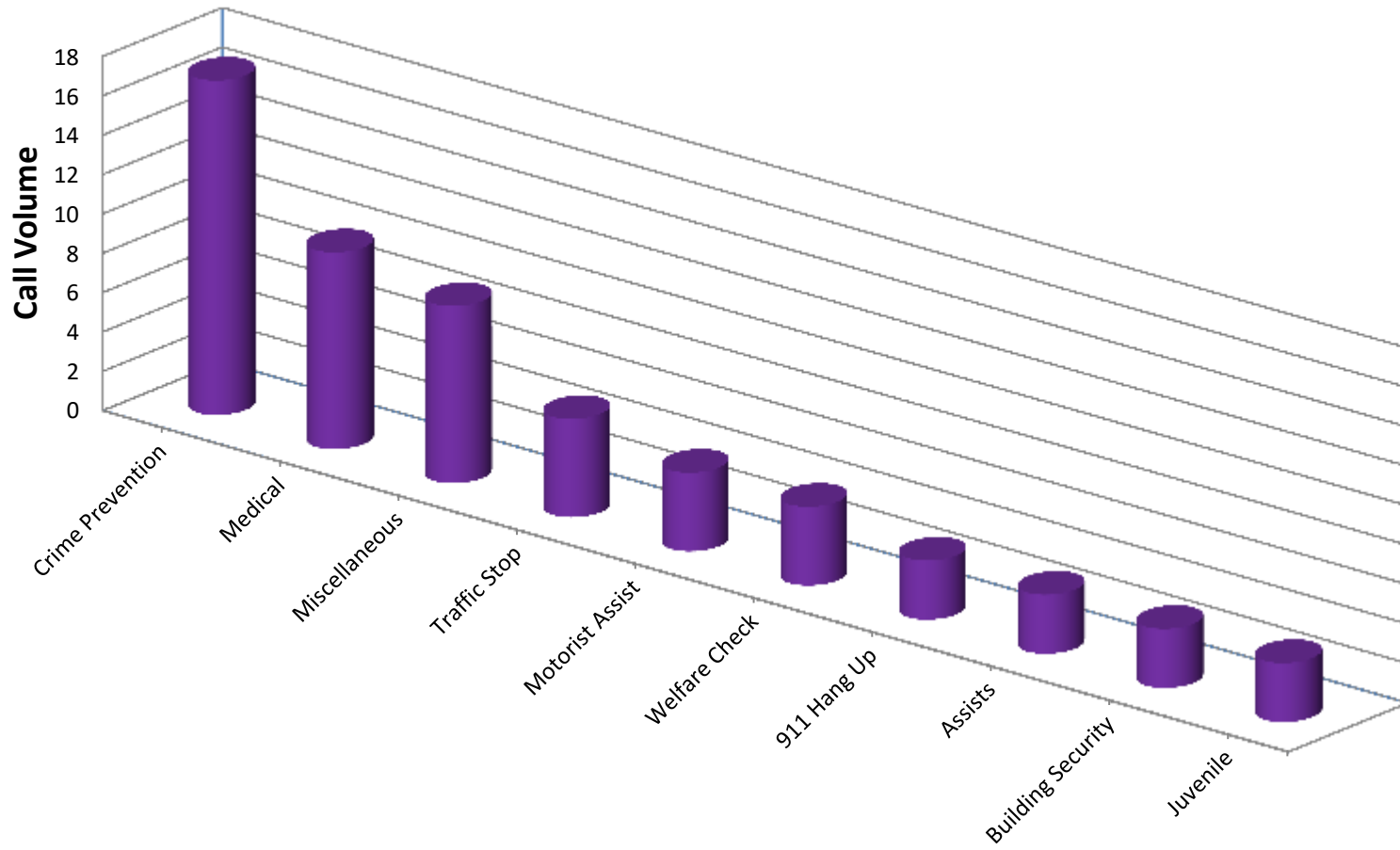
- There was 0 OWI arrest made during the month of February.

- DEOs have also been reviewing sex offender ordinance and the procedures that go along with it. We ask for patience as there a lot of items that need to be addressed to make sure we have a system in place that works for all village residents.
- Just a reminder from November 1 - April 1 this is no parking allowed on the streets from 2a-6a.

- 02-02-17 DEO Delebreaux responded to a medical call at Mc Donald's. There was a 2 year old child having an allergic reaction. DEO Delebreaux assisted until rescue arrived.
- 02-03-17 DEO Delebreaux was present at the girls basketball game at the high school
- 02-03-17 DEO Dzekute attempted to do a welfare check on a resident on Grand Ave. The resident was later found on Sunset Ct. and there were no problems.
- 02-04-17 DEO Delebreaux responded to a possible disturbance. Upon arrival there was no disturbance going on and it was stemming from a custody issue. DEO Delebreaux continued to do some extra patrol in the area to make sure nothing happened.
- 02-04-17 DEO Delebreaux responded to a medical call where the patient was having symptoms of a possible heart attack. He assisted until rescue could transport the patient to the hospital.
- 02-08-17 DEO Dzekute was asked to assist County patrol with a hazard on I-43 near Cooperstown Rd. A large chunk of tire debris was located and removed from the roadway.
- 02-10-17 DEO Delebreaux was called in to help with the meth lab that was discovered in the trailer park in the village. He assisted Brown County Drug Task Force and other WI investigators. A suspect was arrested and taken to jail.
- 02-16-17 Both DEOs were asked to assist with a disturbance just into the county. We arrived and secured the scene until other county officers could arrive.
- 02-16-17 DEO Delebreaux was present at the boys basketball game at the high school
- 02-16-17 DEO Dzekute had a table display at the All Saints School Safety Summit. The event was a great success and there is already talk of the event continuing on next year. Hopefully the event will grow for next year.
- 02-17-17 DEO Dzekute was asked to assist the county with a suspicious person near a house on CTH KB. The person had been parked in front of a house for a long period of time. The area was checked and the person had left. The person has not been seen in the area again.
- 02-20-17 DEO Delebreaux assisted with habitual runaway that returned home to her father's house. DEO Delebreaux assisted and then the case was turned over to a Brown County Investigator.
- 02-20-17 DEO Delebreaux was called to take a theft report for some stolen property that had been stolen but not yet reported. A suspect had been in custody and the property will be returned to the owner.
- 02-21-17 DEO Delebreaux took a report of employee fraud regarding the issuance of a final paycheck. After investigating the incident, the money was returned to the employer.
- 02-21-17 DEO Dzekute responded to a medical call at Scandinavian Court for a patient who was unresponsive. Upon arrival the patient was able to speak a small amount. Rescue transported the patient to the hospital.

- 02-23-17 DEO Dzekute was called to the middle school to assist with a student who had been very defiant to staff. Upon arrival there were no issues with the student.
- 02-23-17 DEO Dzekute gave a presentation to an intro to health careers class at the high school.
- 02-23-17 DEO Delebreaux was present during the village's sex offender registry board meeting.
- 02-28-17 DEO Dzekute gave a presentation to a local Girl Scout troop.

INFORMATION BULLETIN

- This month we got a taste of some nice weather and I know that got a lot of people out moving around. If you are out enjoying the weather we ask that you do it safely. Please use sidewalks wherever possible. If you have to use the road please do so with caution. Remember if you are walking to make sure you try to use the left side of roadway so you can see traffic and they can see you. Reflective clothing and lights are also helpful especially in the early morning or evening time. In case any of you would like to read it here is the WI State Statute for walking on the roadway.
 - **346.28 Pedestrians to walk on left side of highway; pedestrians, bicyclists, and riders of electric personal assistive mobility devices on sidewalks.**
 - [346.28\(1\)](#) (1) Any pedestrian traveling along and upon a highway other than upon a sidewalk shall travel on and along the left side of the highway and upon meeting a vehicle shall, if practicable, move to the extreme outer limit of the traveled portion of the highway.
 - (2) Operators of vehicles shall yield the right-of-way to pedestrians, bicyclists, and riders of electric personal assistive mobility devices on sidewalks as required by s. [346.47](#).
- Now that we are getting into tax time you may see an increase in scams claiming to be from the IRS. A big thing to remember is that the IRS is going to use the postal service if there is going to be any contact. If you receive a call that you feel is a possible scam **don't** give out any information and call in the incident.
- Just a reminder to keep all vehicles, homes, and outbuildings locked. We may trust our neighbors, but can we always trust the stranger that finds their way into the village. **DON'T** be a "soft target" for criminal activity.

- It is important to remember to call in any type of suspicious activity. With the recent string of thefts we have had some incidents that have not been called in when they happen. The sooner the activity gets called in the sooner we can get officers in the area and hopefully get this problem to stop. The number to call is **920-391-7450**. If it's an emergency always dial 911.
 - The voicemail in the DEO office is now set up. We will be checking the voicemail throughout our shift. If you need an officer to come out please continue to use the non-emergency number listed above or below or 911 for an emergency.
 - If there are any drug issues that you notice throughout the village and you would like to report them please call the **Brown County Drug Task Force tip line: 920-437-DRUG(3784)**. The tips that come in from the village will get sent and viewed by both DEOs. We can then follow up on the tips.

This is the easiest way to either get the Denmark DEOs or if they are not available you will get an available county officer. This also helps the Denmark DEOs track the type of calls and call volume. This is what we use to make our plans on how to patrol the village. If there is an emergency that needs law enforcement action please call 911.**
