NOTES:

- 1. Permits are not needed for:**
 - a. Remodeling projects valued under \$1,000.00 excluding those projects requiring the addition or alteration of electrical or plumbing.
 - b. Replacing the following:
 - 1) Plumbing fixtures - provided the fixture is replaced to the exact location by or under the supervision of either a master plumber or by the homeowner.
 - 2) Furnaces - provided the furnace is replaced to the exact location by or under the supervision of a certified heating technician.
 - 3) Windows & Doors - provided the openings are not changed.
 - 4) Decks & Sidewalks - provided they are exactly the same dimensions as before.
 - 5) Roof shingles
 - 6) Floor covering
 - 7) Glass replacement
 - 8) Painting or wallpapering

- 2. Inspector's Notes:**
 - a. Property pins or stakes must be exposed for the first inspection for any new construction or additions or an additional inspection fee will be charged.
 - b. All electrical work must be performed by or under the supervision of a qualified master electrician.
 - c. All plumbing work is to be performed by a DILHR licensed plumber in a single family building. The homeowner can install plumbing after at least one (1) toilet, one (1) tub or shower & one (1) sink have been installed by a licensed plumber in a single family building owned & occupied by him/her as his/her home.
 - d. An erosion control plan must be submitted to the Building Inspector at the time the property/landowner is desirous of undertaking a land disturbing or land developing activity which requires a permit.
 - e. All HVAC work is to be performed by a licensed heating contractor.
 - f. All contractors must be certified with the State of Wisconsin & be able to show proof of insurance. In addition all contractors will be required to be able to show same for all subcontractors.
 - g. Road/street cleanup, additional inspections or any other related charges will be paid in full before the final inspection is released.
 - h. Frozen green concrete is to be analyzed by a qualified individual/firm at the owners' expense if so requested by the Building Inspector.
 - i. Applicable fees will be DOUBLED if any work proceeds before permit fees are paid.
 - j. A permit shall be in effect for a period of twelve (12) months from the initial date of issuance.
 - k. An additional fee for plan review may be assessed at the time of application or renewal of permit.
 - l. Sanitation Units & Dumpsters are required at all new home & commercial sites.**
