Summary

Village of Denmark, Brown County, Wisconsin

- There were **86** incident calls in the village from **2/1 – 2/19**
 - DEOs handled **51** of those calls
 - SRO Dzekute generated **11** of those calls
- From **2/20 – 2/28** exact # of calls in village solely is not easily available from records due to change in the county wide CAD system
 - Estimate total # of calls in February > 100
- DEOs assisted the County on **8** calls

House Check Requests

Crime reduction

- DEOs received additional future house check request forms for citizens in community
- DEO Verheyen followed-up with home owners on requests in person and/or via phone

DEO Training

Education

- **Crisis Intervention Team (CIT)**
 - DEO Olmsted attended the 40-hour CIT training course by Gold Stripe Consulting, LLC
 - DEO Verheyen attended this same training in October 2014
 - Both DEOs are certified in CIT and seek to understand mental illness, it's signs and symptoms, and how to approach and de-escalate a person in crisis
- **Dynamics of Officer/Citizen Encounters**
 - DEO Olmsted and DEO Verheyen both attended this 8-hour course by Command Presence, LLC
 - Increased officer safety and public safety interactions with citizens

DEO Traffic Enforcement

”Click it or Ticket”

- DEOs made **14** traffic stops in February
 - DEOs issued **3** citations
 - DEOs issued **11** warnings
- County deputies continue to add extra patrol in the village to assist the DEOs
- DEOs continue to patrol the school zone and monitor pedestrian traffic
- DEO Olmsted continues to work on revising the village parking ordinances

School Resource Officer (SRO)

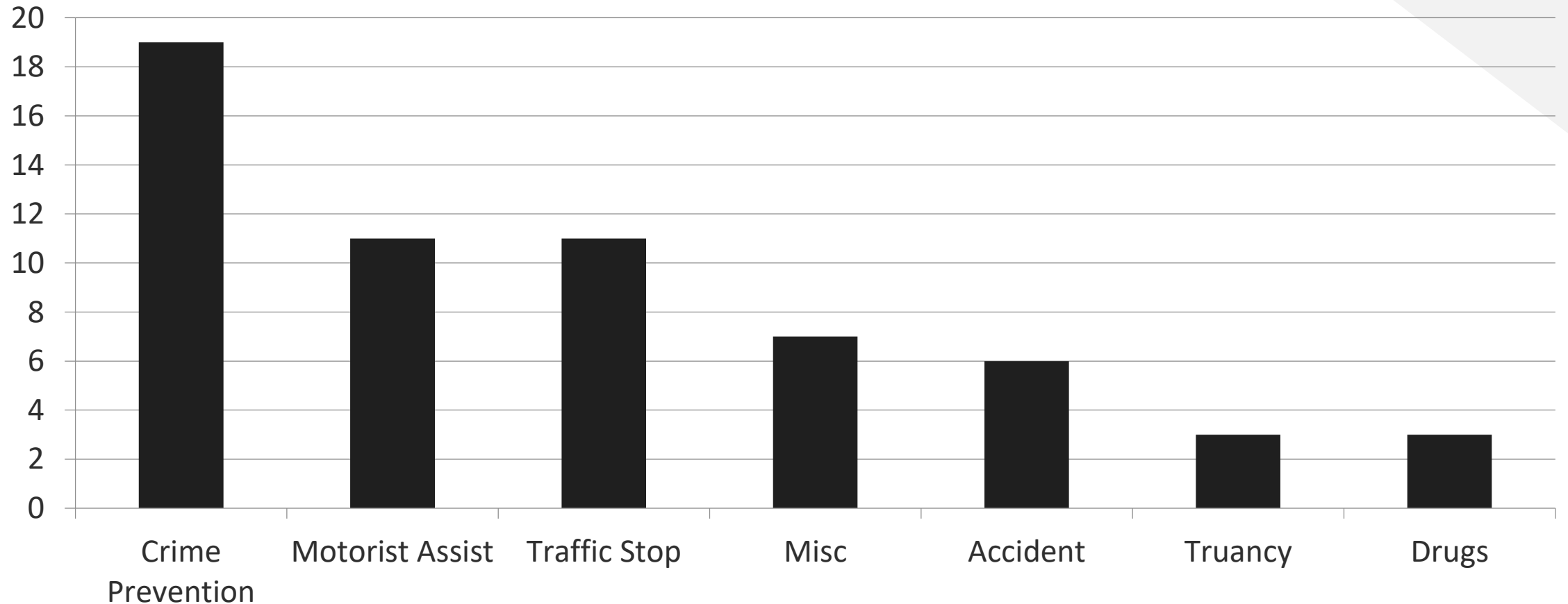
- Both DEOs continue to work with SRO Dzekute at village schools and calls for service regarding students

Reminders

- There is **NO OVERNIGHT PARKING** from 2:00 a.m. – 6:00 a.m. now thru April 1st
- **Winter Driving** – reminder that bridges/overpasses/ramps are the first surfaces to form ice. Slow down, increase following distance and drive defensively. Clear your windshield and windows **BEFORE** traveling!
- **Lock it Up** – Keep all vehicles, homes and outbuildings locked. We may trust our neighbors but it is wiser to be proactive because most property crimes are crimes of opportunity.
- **Phone & Internet Scams** – do not give out any personal information over the phone. Scammers try to shock and intimidate victims into giving up personal information by threatening “arrest” or “warrants” or they may prey on your decency by telling you a loved one is in trouble in another state/country. Be **VERY** sceptical of all phone/email correspondence. Have frequent conversations with elderly/your aging loved ones and educate them about how to protect their assets.
