VILLAGE OF DENMARK SUMMARY

- Denmark had 88 total incidents in July
- DEO Dzekute and DEO Delebreaux handled 48 of the 88 incidents in the village (54.5%)

VILLAGE OF DENMARK PATROL

- DEOs made 9 traffic stops, issued 2 citations, and 9 warnings. There was also 1 parking ticket issued.
- County officers continue to add extra patrol in the village to assist the DEOs

BROWN COUNTY DRUG TASK FORCE IN DENMARK

- Both DEOs continue to monitor the drug tips to keep up to date on any possible drug activity in the village.
- There have been drug tips from some residents that have come in to the DEOs and they will be following up on them

OWI ARRESTS IN DENMARK


- There was 1 OWI arrests made during the month of July and enforcement continues throughout the village.

DEO'S IN DENMARK


- The month of July brought us the Lion's Club picnic weekend. Both DEOs were on hand for portions of the weekend. No major issues resulted from the events.

- 07-01-17 DEO Delebreaux made a traffic stop on a vehicle. Through his investigation he was able to take a party into custody for an active arrest warrant.
- 07-08-17 DEO Delebreaux assisted the county patrol officers with two calls outside the village. One incident involved trying to locate a suspicious vehicle. The other involved a stolen vehicle.
- 07-09-17 DEO Delebreaux was investigating a reckless driver complaint. He was able to locate the vehicle and got it stopped. During the course of his traffic stop it was established that the driver was operating while intoxicated and was arrested.
- 07-10-17 DEO Delebreaux responded to Denmark High School for a theft report. There were items taken from inside the school. A suspect was located and the proper action was taken. The property was also found and returned to the owners.
- 07-17-17 Both DEOs attempted to take a party into custody on an active arrest warrant. No contact was made with the party at that time.
- 07-18-17 DEO Dzekute received a complaint of vehicles speeding on Grand Ave. Due to the complaint the speed board was deployed.
- 07-19-17 Both DEOs responded to a possible disturbance. The incident was investigated and it was determined that nothing criminal had taken place.
- 07-21-17 DEO Dzekute was dispatched to a report of a suspicious vehicle in the 400 Blk. of Highridge Ave. The village was checked and the vehicle was not located.
- 07-22-17 Both DEOs conducted bar checks throughout the village. Everyone in the bars was found to be over the legal drinking age.
- 07-23-17 Both DEOs assisted with the Lion's Club parade through the village. There was a great turn out and it seemed like everyone in attendance had a great time.
- 07-27-17 DEO Dzekute gave a presentation to the driver's education class at the high school.

WHY OFFICERS DO WHAT THEY DO:

- This is a new addition to our monthly report. It was brought to our attention that there are a lot of things that officers do on the job that the general public might have questions about. Each month we will try to explain some of the things that officers do during their shift.
- **Paperwork**
 - This month we will look at a part of the job that no officer really likes, but it is a large part of what we do. Paperwork or report writing goes along with everything that we do. Even the simplest of tasks requires some sort of documentation. Whether that is simply putting a little information on an activity log or a full blown report for a major crime. The amount of paperwork that officers have to complete continues to increase with new laws and new programs for tracking incidents that we get called to. There was a time not long ago that officers could do their reports right in their squad cars. This has changed in a big way due to the ever changing dangers each officer faces. Doing paperwork in our cars was a great way to be present in the community but still allow us to get our work done. It provided a quick response because the officer was in the car ready to go. The computers that we have in our cars allows us to do pretty much anything we would need to do. Although we still have the ability to do the paperwork in our car the dangers of doing so has forced most officers to move into offices to work on paperwork.
 - The reality now days is that law enforcement officers are actively being hunted. We are rapidly seeing more and more incidents involving officers killed in the line of duty by someone who had their mind set on just that; killing an officer. Due to this new danger that was not present in the past officer no longer feel safe sitting in their squad car when they can't be watching what is going on around them. Since even the simplest report can sometimes take 30 mins it is much easier for an officer to go into a designated office which offers a much more controlled environment for the officer to complete their paperwork. So when you see a squad car parked outside of a police dept. or a police office for more than a few minutes try not to be too critical or cynical toward that officer. We ask that you try to understand that the officer is trying to complete their work in the safest and most efficient manner possible.
 - If you have anything questions about other things an officers does please let one of the DEOs know and we will try to address it in a future report.

INFORMATION BULLETIN

- IRS scams are still going around so please be aware of anything you think is a scam. A big thing to remember is that the IRS is going to use the postal service if there is going to be any contact. If you receive a call that you feel is a possible scam **don't** give out any information and report the incident by calling **920-391-7450**

- Just a reminder to keep all vehicles, homes, and outbuildings locked. We may trust our neighbors, but can we always trust the stranger that finds their way into the village. **DON'T** be a “soft target” for criminal activity.
- It is important to remember to call in any type of suspicious activity. With the recent string of thefts we have had some incidents that have not been called in when they happen. The sooner the activity gets called in the sooner we can get officers in the area and hopefully get this problem to stop. The number to call is **920-391-7450**. If it's an emergency always dial 911.
- The voicemail in the DEO office is now set up. We will be checking the voicemail throughout our shift. If you need an officer to come out please continue to use the non-emergency number listed above or below or 911 for an emergency.
- If there are any drug issues that you notice throughout the village and you would like to report them please call the **Brown County Drug Task Force tip line: 920-437-DRUG(3784)**. The tips that come in from the village will get sent and viewed by both DEOs. We can then follow up on the tips.

This is what we use to make our plans on how to patrol the village. If there is an emergency that needs law enforcement action please call 911.**
