The Renter hereby agrees to remit the rental fee of \$50.00 plus a security deposit of \$50.00, and be held responsible for any and all damages to persons, property, and premises. Renter is responsible for the cleanup of property and premises. Cleanup must be done the day of the rental, so that the center is ready for the next day's renter. Renter shall indemnify and hold harmless the Denmark War Memorial, Inc. from any damage, loss, or liability of any kind whatsoever occasioned upon and/or within the rented premises, or ways or walks adjacent thereto, by reason of any injury to persons or property caused or alleged to be caused by any act or omission, neglect, or wrongdoing of the Denmark War Memorial, Inc., or any of his/her and/or its officers, agents, representatives, assigns, guests, employees, invites, or other persons admitted by the renter to the Denmark War Memorial, Inc. building. The Renter will, at his/her own cost and expense defend and protect the Denmark War Memorial, Inc. against any and all such claims or demands including attorney's fees.

The Renter shall verify, by signing below that they have sufficient personal liability (home owners or farm owner's policy) coverage to cover damages that may occur. Renter has received and reviewed a copy of the Denmark War Memorial, Inc. Rental Agreement and agrees to abide by all regulation and policy set forth for the use of the facilities and/or grounds. I acknowledge the Denmark War Memorial, Inc. has no responsibility, express or implied for any damage or injury arising out of, or connected in any way with my/our use of the Denmark War Memorial, Inc. building.

If the building and grounds are not cleaned up to the standards required by the Denmark War Memorial, Inc. or any damage is done to the building or grounds, the security deposit will be retained by the Denmark War Memorial, Inc. Any damage done to the building or grounds that exceeds the security deposit will be billed to the renter.
