October 2020

Summary

- **93** calls for service in the Village of Denmark from **10/1/2020 – 10/31/2020**.
- Directed Enforcement Officers (DEOs) and School Resource Officer (SRO) handled **29** of those incidents.
- Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- **National RX Drug Take Back Day:** DEOs hosted a collection site at the Denmark Village Hall for the Take Back event on **October 24**. This national event encourages communities to dispose unwanted, unused, or expired prescription drugs. The spring 2020 Take Back event had been canceled due to the Covid-19 pandemic. DEO Verheyen hosted the collection site for 4 hours and the turnout was great. Thank you to those who participated by dropping off your unwanted prescription and over-the-counter medications! Results showed 117.1 pounds of medications were turned in from the Denmark Village Hall alone. This contributed to the total amount of 3,315.67 pounds in Brown County turned in from those participating municipalities.
- **Trunk or Treat:** DEO Estano and BCSO deputies participated in the Trunk or Treat event on October 31 at Denmark High School. This event was put on by the Denmark Community Business Association (DCBA). Deputies were very glad to be a part of this event in the community!

Meetings, Associations & Presentations

- DEO Verheyen attended the monthly Village Board meeting on **October 5**.
- Denmark Municipal Court was canceled on **October 7** due to Covid-19 and an order given by State of Wisconsin Eighth Judicial District.
- DEO Verheyen attended the monthly BCSO DEO meeting with others and BCSO administration on **October 21**.

Traffic / Ordinance Enforcement

- Officers use **traffic enforcement** as one mean to modify dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - In **October**, there were **17** traffic contacts initiated and **1** traffic crash in the Village of Denmark.
 - Of those traffic contacts, **18** traffic citations issued and **11** traffic warnings issued
- **Ordinance citations** are used to enforce the codes that are specific to Denmark. There were **8** ordinance citations issued in **October**, five of which were for Loitering.

Administrative / Training

- **In-service Training**
 - DEOs attended the final 8 hours of in-service training in October. This is of the 24 state mandated hours of training. These in-services include a wide variety of topics, training environments, scenarios, use of

force, administrative, legal updates, recertification's, medical equipment, record management systems and more.

- **Monthly Firearm Training**
 - DEOs attend monthly firearms training with BCSO Unified Tactics Team. DEO Verheyen attended the monthly shoot on **October 21**.
- **BCSO Crisis Negotiation Team (CNT)**
 - DEO Verheyen is a part of BCSO CNT specialty unit. This is a team within the BCSO Special Weapons and Tactics (SWAT) team. This team trains most months of the year and attends annual conferences. DEO Verheyen attended monthly CNT training on **October 29**.
- **Chronic Nuisance Properties (CNP)**
 - Currently, there is **1** property that is deemed a CNP in the Village of Denmark.
 - DEOs are in continuous communication with the property owner, landlord, tenant, and neighbors to resolve the nuisance. The Denmark SRO is also an asset in assisting DEOs resolve this CNP.
- **Sex Offender Registrants**
 - DEOs are continuously staying up to date with any police contacts sex offender registrants residing in the Village of Denmark may have. DEOs work with the Village Board who oversees the appeal process for sex offender registrants wanting to reside in the Village of Denmark.

Joint Efforts

- **Crime Stoppers**
 - Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers. These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.
- **Brown County Sheriff's Office Investigative Division**
 - In **October**, there were **7** open cases with the investigative unit. Both DEOs continue to work closely with, communicate, and assist this division when asked to.
- **Brown County Drug Task Force (BCDTF)**
 - DEOs continuously work with the BCDTF on any drug tips/cases within the Village of Denmark.
- **Child Protective Services(CPS), Animal Control**
 - DEOs worked together with CPS and Animal Control for various calls throughout September.
- **Village of Denmark Building Inspector**
 - DEOs work together with the inspector on enforcing ordinances and increasing the overall appearing/safety of the village and residents
- **Denmark School Resource Officer (SRO)**
 - DEOs maintain close communication with the SRO. With school opening back up in-person and the option of virtual/Independent Education Programs, DEOs work closely with the SRO on incidents involving juveniles.
- **Denmark Local Businesses**
 - DEOs work closely with the local businesses within Denmark. Criminal activity and/or suspicious activity that takes places on businesses property is communicated as applicable to those owners/staff.

Information Bulletin

- **Park hours**

- Reminder, park hours for the general public are from 8:00 a.m. – 10:00 p.m. No person shall be present in the park after hours. The community pool will remain closed for the remainder of the season due to COVID-19.

- **Parking within the Village**

- Reminder, **Village Code 289-5(D)** states “no person shall park any vehicle on any street, roadway, highway, or alley within the village at anytime for more than 48 continuous hours without movement.”

- **Noise prohibitions**

- Reminder, **Village Code 213-6** states “no person shall make or cause to be made any loud, disturbing, or unnecessary sounds or noises such as may tend to annoy or disturb a person of ordinary sensibilities in the vicinity thereof in or about any public street, alley, park, waterway, or any private residence unless...”

Crime Prevention

- **Neighbors App**

- Reminder, you can download the Neighbors App for FREE. It is a new tool utilized by Law Enforcement for a Neighborhood Watch program. Neighbors App can be downloaded by texting **browncountywi** to **555888**. Being a part of this forum is another way for the community and law enforcement to come together to mitigate crime and alert real-time activity. It is not used to file a police report. Continue to call the Brown County Non-Emergency at **(920) 391-7450** to file a police report or **9-1-1** in an emergency.

- **House Check Requests**

- There was **1** requested house check form completed in **September**. Remember, if you're leaving town for a weekend or taking a vacation, or traveling – stop in at the village hall to fill out a house check request form (or) it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.

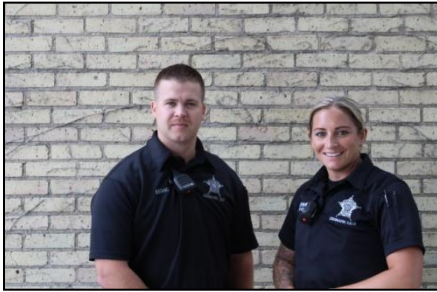

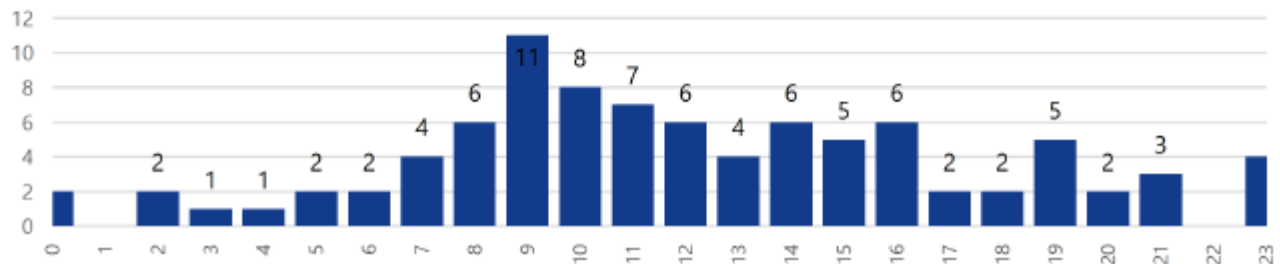
Top 10 Calls for Service By Type
