Summary

- ❖ **141** calls for service in the Village of Denmark from **8/1/2021 – 8/31/2021**.
- ❖ Brown County Sheriff's Office (BCSO) deputies provide additional enforcement, police services and respond to calls for service when DEOs are not available.

In the Community

- ❖ **FROGGER:** Crosswalk and pedestrian safety/education took place on August 19th.
 - Approximately **11 traffic stops** were conducted.
 - **11 warnings** were issued / **0 citations** issued during this enforcement.
 - Enforcement will continue as we enter the 2021-2022 school year.
- ❖ **PRESCRIPTION DRUG TAKE BACK** - As a reminder, this drop off site is open Monday – Friday during normal Village of Denmark municipal hours (8am-4:30pm).
 - ✓ **Fall Drug Take Back is October 23** – mark it in your calendars!

Meetings, Associations & Presentations.

- ❖ Denmark Municipal Court is scheduled for **October 6th, 2021** at 6:30PM. Court is normally scheduled for the first Wednesday of the month at 6:30PM (subject to change).
- ❖ Plans are in place to present a SCAM PowerPoint in 2021.
- ❖ Public safety day took place June 12 @ Memorial Park. The event was a great foundation for years to come and a great opportunity for public safety to interact with the community in which we serve!
- ❖ DEO Estano met with the Law Enforcement Committee in regards to future budget, staff and equipment needs.

Traffic / Ordinance Enforcement

- ❖ Officers use **traffic enforcement** as one mean to modify, correct and educate operators on dangerous driving behavior. Traffic citations are issued to gain compliance with the law.
 - In June, there were **31** traffic contacts initiated and **7** traffic crash in the Village of Denmark.
 - Of those traffic contacts, **14** traffic citations issued and **31** traffic warnings issued.
 - **0 OWI** arrests / citations.
- ❖ **Ordinance citations** are used to enforce the codes that are specific to Denmark. There were **0** ordinance citation(s) issued.

Administrative / Training

- ❖ **Chronic Nuisance Properties (CNP)**
 - Currently, there is **1** property that is deemed a CNP in the Village of Denmark.
 - Update – Property owner / Tenant were cited for nuisance property.
 - DEOs are in continuous communication with the property owner, landlord, tenant, and neighbors to resolve the nuisance.

❖ Sex Offender Registrants

- DEOs are continuously staying up to date with any police contacts sex offender registrants residing in the Village of Denmark may have. DEOs work with the Village Board who oversees the appeal process for sex offender registrants wanting to reside in the Village of Denmark.
- DEO, along with Investigators from the Brown County Sheriff's Office assisted Calumet County Sheriff's office with a search warrant on an offender living within the Village. Subject as taken into custody on charges of Possession of Child Pornography.

Joint Efforts

❖ Crime Stoppers

- Both DEOs continue to monitor anonymous tips that come in through Green Bay Area Crime Stoppers. These tips are received at Crime Stoppers through phone or online. DEOs are then forwarded these tips for follow-up.

❖ Brown County Sheriff's Office Investigative Division

- Both DEOs continue to work closely with, communicate, and assist this division when asked to.

❖ Brown County Drug Task Force (BCDTF)

- DEOs continuously work with the BCDTF on any drug tips/cases within the Village of Denmark.

❖ Child Protective Services(CPS)

- CPS serves a vital role in assisting deputies with certain investigations.

❖ Village of Denmark Building Inspector / Department of Public Works (DPW)

- DEO Estano continues to work together with the inspector on enforcing ordinances and increasing the overall appearance/safety of the village and residents. DPW also works with DEOs to enforce certain ordinances/address traffic safety.

❖ Denmark School Resource Officer (SRO)

- DEO/Deputies maintain close communication with the SRO. With school back in-person and the option of virtual/Independent Education Programs, DEO/Deputies work closely with the SRO on incidents involving juveniles.

❖ Denmark Local Businesses

- DEO/Deputies work closely with the local businesses in Denmark. Criminal activity and/or suspicious activity that takes places on businesses property is communicated as applicable to those owners/staff.

Information Bulletin

❖ Park hours

- Reminder, park hours for the general public are from 8:00 a.m. – 10:00 p.m. No person shall be present in the park after hours. Parking ordinances are also enforced within park after hours.

❖ Parking within the Village

- Reminder, **Village Code 289-5(D)** states “no person shall park any vehicle on any street, roadway, highway, or alley within the village at anytime for more than 48 continuous hours without movement.”
- Parking from the hours of 2am-6am is also prohibited from November 1 – April 1.

❖ Noise prohibitions

- Reminder, **Village Code 213-6** states “no person shall make or cause to be made any loud, disturbing, or unnecessary sounds or noises such as may tend to annoy or disturb a person of ordinary sensibilities in the vicinity thereof in or about any public street, alley, park, waterway, or any private residence unless...”

Crime Prevention

❖ Neighbors App

- Reminder, you can download the Neighbors App for FREE. It is a new tool utilized by Law Enforcement for a Neighborhood Watch program. Neighbors App can be downloaded by texting **browncountywi 555888**. Being a part of this forum is another way for the community and law enforcement to come together to mitigate crime and alert real-time activity. It is not used to file a police report. Continue to call the Brown County Non-Emergency at **(920) 391-7450** to file a police report / speak with an officer or **9-1-1** in an emergency.

❖ House Check Requests

- Remember, if you're leaving town for a weekend or taking a vacation, or traveling – stop in at the village hall to fill out a house check request form (or) it can be located on the village website. These forms are forwarded to DEOs for documentation, checks, and extra patrol. These checks offer extra supervision over your home and provide DEOs information on who to contact while you are away if needed as well as what to expect for activity/vehicles at your home.

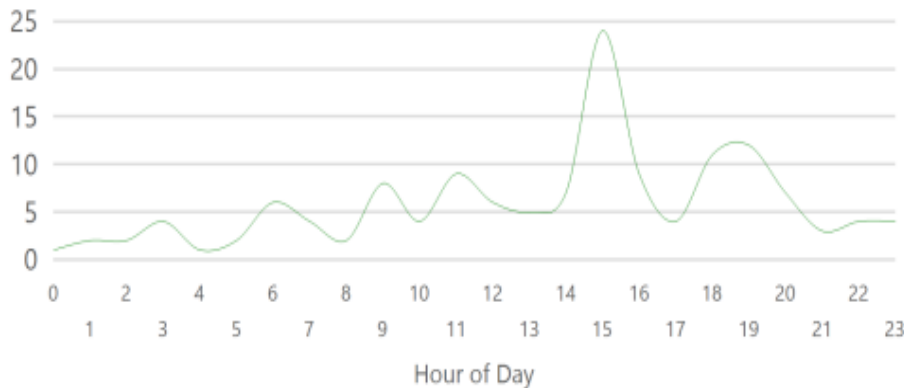

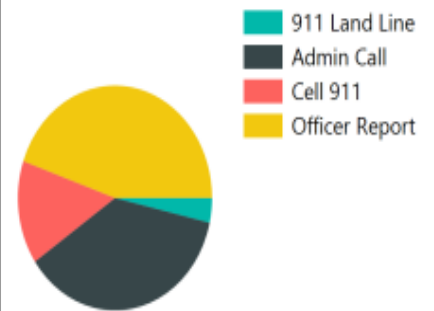
